Sealed Bids for the upgrades at the wastewater treatment plant identified as the Wastewater Treatment Plant Upgrades Project will be received, by the Bamberg Board of Public Works, at the City Hall at 2340 Main Hwy, until **10:00 am** local time on **January 22, 2024**, at which time the Bids received will be publicly opened and read aloud.

The project includes:

The installation of approximately 24,300 LF of water main, initiating with a system connection near Bamberg's Rhoads Park elevated tank. Gate valves and fire hydrants will be installed along the water main to allow proper operational control of the distribution system and to serve the customers in the 75 residences that will be provided a public water source as a result of this project.

The Board of Public Works reserves the right to reject any and all bids.

This includes compliance with Contract Work Hours, Safety Standards Act, and Davis-Bacon Wage Rates. Debarred or Suspended individuals or entities are prohibited from working on the project. Provision of a Unique Identity ID # will be required for payment purposes.
